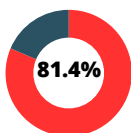

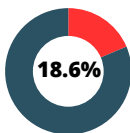

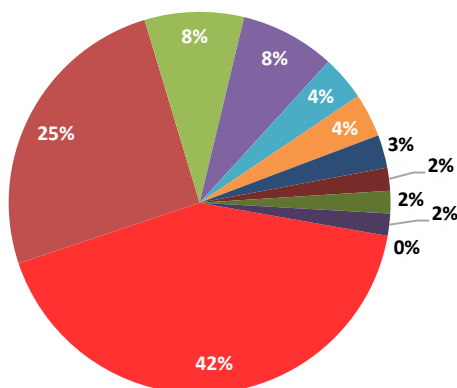

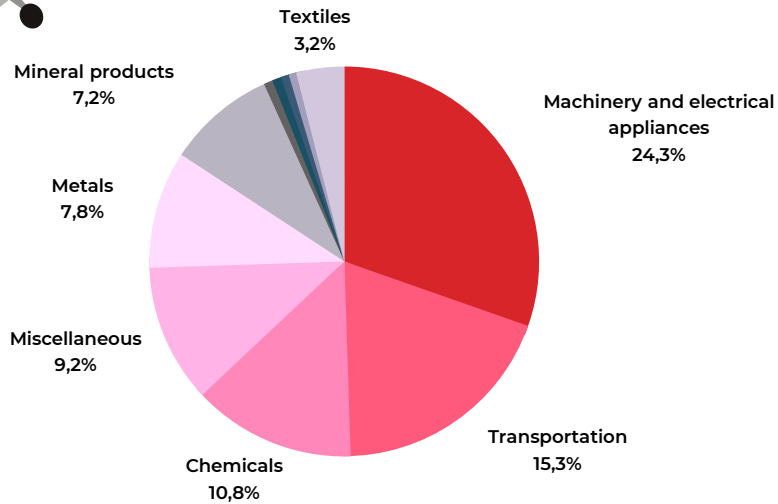
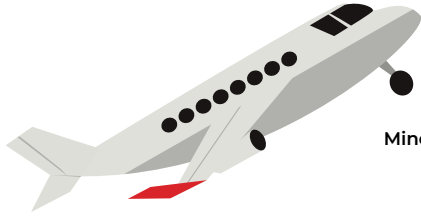

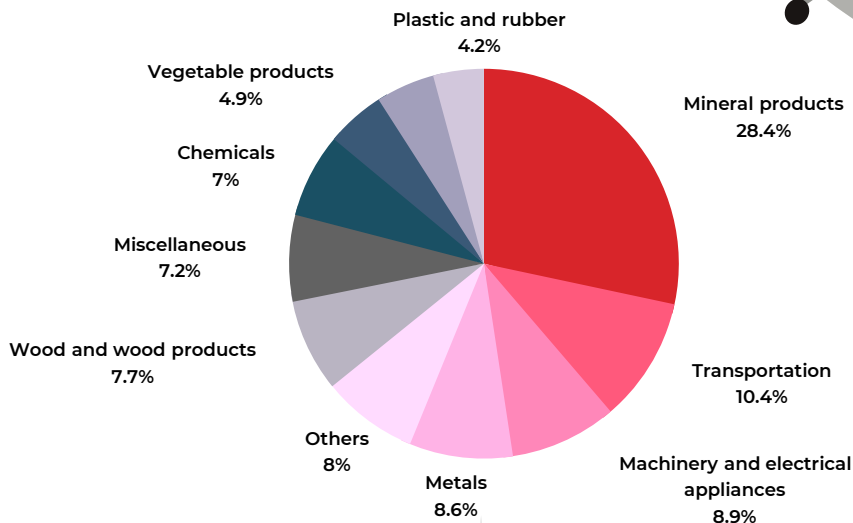

GLOBAL EXPORTS BY COMMODITY FROM CANADA 2022

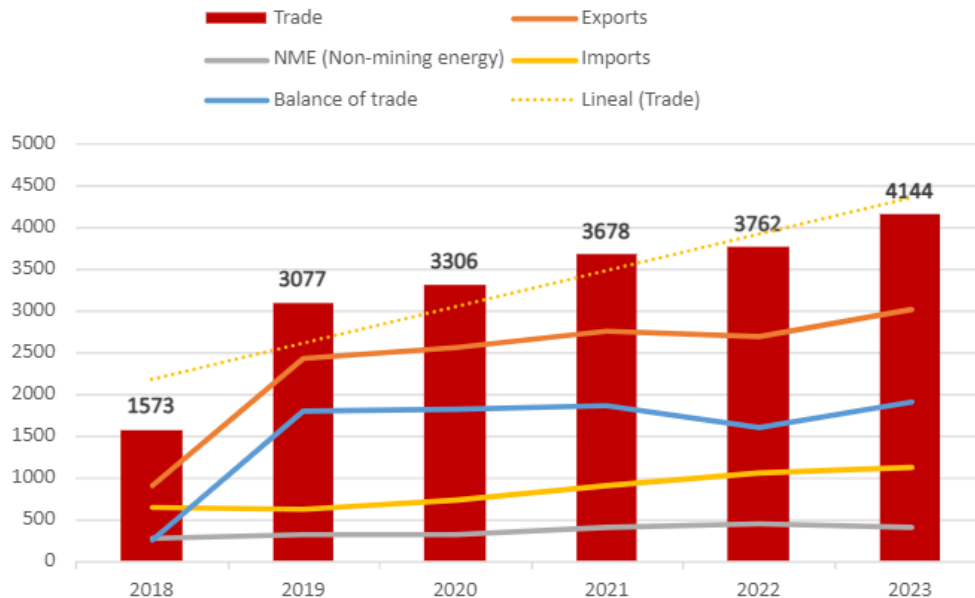


BALANCE OF TRADE BETWEEN PERU AND CANADA

PERIOD: 2020-2023

In 2023, the annual balance of trade was positive, with a surplus of US\$1903 million. Exports showed an increase, reflecting a positive variation of 12.6%. On the other hand, in the area of imports, we observed an increase, reflecting a positive variation of 4.1%. Likewise, trade increased in the last year from US\$ 3,762 million to US\$ 4,144 million, reflecting an increase of 10.2%.
