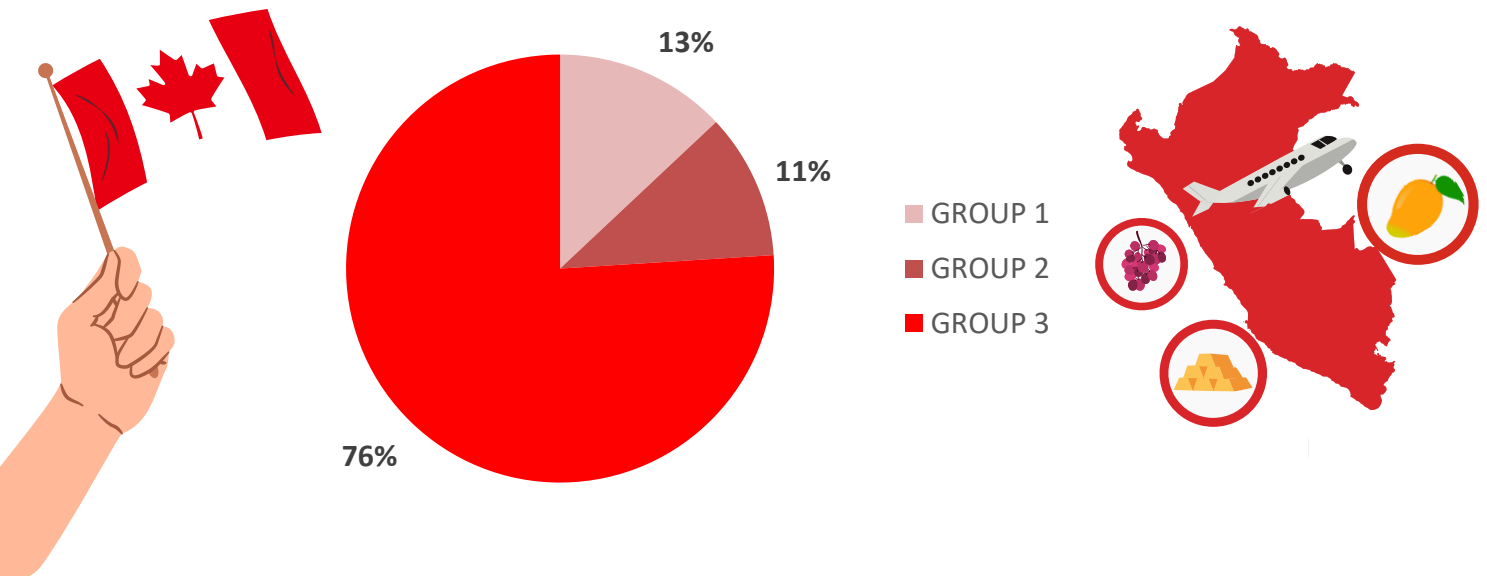

CANADA: BUSINESS OPPORTUNITIES

In 2023, Canada imported goods amounting to US\$ 559 billion.
Canadian imports can be divided into **3 groups**:

GROUP 1: Products that Canada imports and Peru exports to Canada.

SECTOR	PRODUCT
AGRICULTURE	Unroasted coffee (8%), blueberry (29%), asparagus (22%), avocado (2%), and grapes (29%)
FISHING	Fish oil (25%) and fish meal (1%)
TEXTILE	Cotton shirt (3%) and cotton T-shirts (5%)
OTHERS	Unwrought gold (28%) and Liquefied natural gas (16%)



GROUP 2

GROUP 2: Products that Canada imports, Peru exports, but not to Canada.

SECTOR	PRODUCT
AGRICULTURE	Palm oil, canned pineapple and orange juice
FISHING	Frozen octopus, in brine or prepared, and frozen mackerel
TEXTILE	Polyethylene and acrylic staple fiber bags and sacks
OTHERS	Petroleum crude oil, sodium hydroxide and monoammonium phosphate



GROUP 3: Products that Canada imports and Peru does not export

SECTOR	PRODUCT
AGRICULTURE	Wine, raspberry/blackberry, fresh watermelon and sunflower oil
FISHING	Smoked trout, pacific salmon fillet and crab
TEXTILE	Carpets, toilet or kitchen linens, and synthetic fiber blankets
OTHERS	Biodiesel, aluminum oxide and immunological products
